Competition Rules (Updated 2025)

A. INTRODUCTION

- 1. This programme requires your full co-operation and goodwill.
- 2. The HVA will be firm in its dealings with offenders of the rules.
- 3. Make sure you read the rules, which change yearly. Failure to do so may result in fines, disciplinary action, sets being conceded and/or matches forfeit. Ignorance of the current rules is no defence. A history of amendments can be found at the back of this document.
- 4. These rules can only be changed at the AGM. Where there are in-season corrections or clarifications these are communicated via the website and to clubs via email.
- 5. Clubs are responsible for the conduct of their members at all HVA competitions. Club members are expected to behave both on and off court in an exemplary manner that promotes the spirit of the game of volleyball.

B. REGISTRATION and AFFILIATION

- 1. All clubs must be affiliated to England Volleyball and provide a copy of their affiliation certificate or other proof of affiliation to the Competitions Secretary before their first match is played. <u>See K6</u>.
- 2. All clubs, teams and players must be registered with the HVA.
- 3. League and KO Cup entry fees are to be paid to the Treasurer before their first competitive match of the season. <u>See K7</u>.

C. CLUBS, TEAMS and PLAYERS

- 1. Players are only allowed to play for the club with which they are registered, in any competition organised by the HVA. Players can only be registered to one club. See also C7.3.
- 2. Players may transfer from one club to another club once per season. The transfer request should be made to the Competitions Secretary in writing before 1 February and must be confirmed before the player plays for the new club.
- 3. Clubs must confirm the teams and the competitions they wish to enter to the HVA Competitions Secretary before 30th September.
- 4. Clubs can add players to their club roster via the website directly at any time during the season.

5. Team Player Restrictions

- 5.1 Every club player registered can optionally be assigned to a club team when they are added to the club's roster. When an unassigned or unregistered player plays their first league match, they are immediately assigned to that club team. Players cannot change their team assignment during the season (exceptions will be considered by the HVA committee if they receive a request in writing).
- 5.2. During any league match, at least four players listed as assigned to that team must be recorded on the scoresheet as present on the court. For the avoidance of doubt, this means that club players can play up, across or down in other club teams any number of times during the season regardless of which team they are assigned to.
- 5.3 If one of the core players of a team is injured during a match and cannot be legally substituted by another core player, another player may be used. The reason must be clearly recorded on the scoresheet.
- 5.4 Appendix A gives more information on this rule, special rules to cover libero players (who are never recorded as "present on the court") and a worked example.
- 6. Only one player from the NVL Super League and London Premier Division can be on the score sheet for any team in the HVA. All such players must be identified on the team sheet.

7. Men/Women Players

- 7.1. Senior men cannot play for any women's team in any competition.
- 7.2. Women may play for men's teams in the league competition, but not the cup competition (see I1.2). Team player restriction rules still apply.
- 7.3. Women who play for a club that does not have a women's team in the Hertfordshire league competition may play in a women's team at a different club and are registered with that club as usual, effectively being registered at two clubs. It must be made clear to the Competitions Secretary, which club is the primary club as the player is not eligible to play in men's matches at their secondary club. They are considered two different players when it comes to MVP awards.

8. Junior Players

- 8.1. Any player, male or female, under the age of 16 on 1st September of the current season is considered a Junior player.
- 8.2. A Junior player registered with a club, may play in any of the club's teams, but the team player restriction rules still apply.
- 9. The Mixed League shall have a minimum of two ladies or junior players on court at any one time, but the team player restriction rules still apply.
- 10. A player is deemed to have played if they are included on the roster of the scoresheet.
- 11. Any breaches of these Team Player Restriction rules mean the team has fielded an ineligible player and concede the set in which that occurred. <u>See K11</u>. A match with all sets conceded is still considered to have been played, rather than forfeited. No more than three sets will be recorded as conceded for a match regardless of how many were played.

D. MATCH ARRANGEMENT

- 1. Matches are to be played on a Home and Away basis.
- 2. The first named team on the fixture is the home team. The second named team is the away team.
- 3. Matches are played on the date and time noted in the published fixtures list.
- 4. The home team is responsible for:
 - a) All match arrangements.
 - b) Appointing and informing match officials of match details.
 - Informing the Competitions Secretary of changes to the fixture date and/or time before the match is played.
- 5. All fixture dates, times, and preferably venues for league matches must be set before 1 November. If any fixture details are missing at that time, the Competitions Secretary may determine a fair date for each missing fixture, which will be at least 3 weeks in the future, and will be added to the published fixtures list.
- 6. All fixtures, league and cup, with the exception of the KO Cup final, must be completed by the end of April.

7. Re-scheduling matches.

- 7.1 Either team can contact their opposition and request a change to the date and/or time of a published fixture. The opposition may refuse the request, and the fixture goes ahead as scheduled or is forfeit by the team who made the request to change the fixture. See D7.2.
- 7.2 Special consideration should be given when a request is received to change a league fixture to accommodate a cup match, even if that cup match is against a third club. Cup matches must be played by a specific date and should be given priority.
- 7.3 The team wishing to re-arrange a match should make the effort to suggest some alternative dates and times when they make their request. Please look at the opposing team's and club's existing fixtures before suggesting alternatives.

8. Match forfeits.

- 8.1. Any forfeited match is lost 3-0 with a score of 25-0 for each set awarded to the opposition.
- 8.2 Any fixture that is not played as scheduled is forfeited by the team at fault unless the opposition decide they would rather re-schedule the fixture.
- 8.3 Any fixture that has not been played by the end of the season (see D6) is forfeited by the team at fault.
- 8.4 A team can choose to forfeit a match in advance. The Competitions Secretary should be notified.
- 8.5 For the avoidance of doubt, there are other scenarios that may result in a match forfeit not listed in this section.

- 9. An away team that does not provide at least 72 hours' notice to reschedule, forfeit or otherwise not attend a scheduled fixture will be fined to partially cover the home team's hall hire costs. The fine will be taken from their Goodwill Deposit and transferred to the home club by the HVA Treasurer. The home team can claim a forfeit if they do not want to re-schedule the fixture. For clarity, there is no such fine for a home team cancelling a match within 72 hours, but the opposition may still claim a forfeit. See K13.
- 10. Any disagreement between teams about who was at fault for a missed or un-played fixture will be arbitrated by the HVA. Including the Competition Secretary in any scheduling discussions can assist in determining fault. Rule 7.2 and extenuating circumstances will be considered by the HVA. Where team 1 has previously been at fault and a fixture re-organised, the HVA would generally rule in team 2's favour even if they were subsequently at fault for that re-scheduled fixture not being played. The HVA's and Competitions Secretary's decision is final.

E. MATCHES OFFICIATION

- 1. All matches are to be played as per FIVB "Rules of the Game".
- 2. All HVA matches are to be played in sports halls, the size of which will be in accordance with EVA rules.
- 3. If local conditions require rule changes, this must be declared on the league entry form. HVA approval is required for such changes.
- 4. All shirts to be uniquely numbered per team player. Libero shirts should be significantly different from all other shirts in use by the team. We encourage the team to have club uniform where at least the shirts are of the same general colour, but there is no penalty if they do not.
- 5. The home team is to supply the match ball, which must be either the Mikasa V200W or V300W. See K5.
- 6. Net aerials are compulsory for all matches. The net should be at the required height. See K5.
- 7. There must be a minimum of two hours available for play.
- 8. Players not recorded on the score sheet at the start of the match may not take part. Players recorded on the score sheet, but who arrive late, may not play in the set in progress, but may play in subsequent set(s).
- 9. At least 15 minutes warm-up time should be allowed after the confirmed start time. Note: A match can begin as soon as all teams are ready and warm up is complete. An early start is encouraged for time restricted venues (see E11).
- 10. Any team not ready to begin play 30 minutes after the published fixture time concedes the first set. Subsequent sets are conceded every 15 minutes, until an hour after the published fixture time when the match is conceded. As soon as the late team is ready to begin, play continues as normal. If this is a time restricted venue (see E11) and the match runs out of time, the late team concedes any remaining set points and remaining sets to concede the match. See K2.

11. Time Restricted Venues

- 11.1 If a venue is restricted by time, the end time must be clearly communicated by the home team captain to the first referee and the opposition captain at the coin toss. This time should be recorded in the remarks section of the scoresheet and initialled by both captains when they sign the roster before the game.
- 11.2 The first referee should end the match, once the current set point is complete, at the agreed time.

12 Result of an Incomplete Match

- 12.1 An incomplete match is awarded in favour of the team with the most sets won (unless the rules at D10 apply because the match did not start on time).
- 12.2. For this purpose, an incomplete set is counted as a win for the team with a lead of 2 or more points, otherwise a tie. If set scores are tied, the winner is the team with a "points total" of at least 2 more than their opponent's.
- 12.3. If teams are still tied, the match is considered a draw and the two teams each get 1 league point for drawing the match.
- 12.4 If a time restriction is not clearly communicated as per E11.1 or there is otherwise insufficient time to complete the match, then the home team concedes all remaining set points and sets to concede the match (unless the rules at D10 apply because the match did not start on time). See K2.

F. OFFICIALS

1. The home team must appoint match officials and a competent scorer, as detailed below. It is preferred but not mandatory to use a neutral first referee for league matches. The officials for the CUP finals are provided by the HVA. See K1.

- 2. In the event of the non-appearance of an official, the captains of the two teams concerned shall agree to the appointment of an available official. This must be recorded on the score sheet.
- 3. All matches are to be recorded on official EVA score sheets or printed A3 equivalent. See K3a.
- 4. The score sheet should be marked clearly with the type of match, including division and the correct match number as per the published fixture list.
- 5. The home team is responsible for entering the results on the HVA website as soon as possible after each match: entering player rosters (as completely as possible), MVPs, match results and uploading a legible copy of the full scoresheet. Note that the away team is also able to perform this function, although they do not have ultimate responsibility for doing so. <u>See K3b</u>.
- 6. All scoresheets must be presented at least 5 days before the KO Cup Final else the home team forfeits the match. <u>See K3c</u>.
- 7. Where a complaint is received about the qualified status of a first referee, the home team will have 10 working days from the day the complaint was brough to their attention by the HVA to provide evidence of referee qualification. The higher fine at <u>K1</u> will be applied if proof is not provided within this timeframe.
- 8. A neutral referee is defined as anybody who does not currently play for either team in any capacity.

G. LEAGUE

- 1. League points will be awarded as follows:
 - 1 point for playing the match, plus
 - 1 point for every set won or half a point for a tied set, plus
 - 2 points for winning the match (or 1 point to each team for drawing the match).

Where a team loses a match due to forfeit, no points will be awarded to the team. The opposition still receives a league point as if they had played the match.

- 2. If two or more teams tie on league points, their league position will be decided on:
 - Most matches won then
 - Least matches lost then
 - Most sets for then
 - Least sets against then
 - The set result of the matches played between the teams in the league then
 - Largest set point difference (set points for, minus set points against)
- 3. League promotions and relegations are based on 2 up, 2 down where there are multiple divisions. If there are extenuating circumstances why this would not be practicable, this can be considered by the committee at the annual fixtures meeting at the start of the season.
- 4. Teams who cancel or forfeit more than 50% of their matches, have all their matches declared null and void at the end of the season. All league points earned in these fixtures are cancelled before the end of season league table is finalised.

5. MVP (Most Valuable Player)

- 5.1. After each match, the captain must nominate a "Most Valuable Player" (MVP) from their opponent's team.
- 5.2. The nomination for each team is indicated in the remarks section of the scoresheet.
- 5.3. The nomination should be made in good faith and in the spirit of the game. The first referee can override either decision at the offended team's captain's request. If the first referee feels the nomination to be unfounded, they may freely and with no input or pressure from the offended team, decide upon an alternative MVP.
- 5.4 The first referee has the responsibility for ensuring MVPs are marked correctly and clearly on the scoresheet. They cannot be added or amended after the event.
- 5.5 The HVA may make an award to the most nominated MVP(s) in each league and division at the end of the season.
- 5.6 If a player who was ineligible to play at any point within a match is awarded the MVP for that match, that award is disregarded.

H. DISPUTES

- 1. The HVA executive will adjudicate all disputes and their decision is final.
- 2. Disputants must submit the request for a hearing in writing to the Chairman.
- 3. All parties in the dispute will be asked for a written statement and may be required to attend the executive meeting considering their dispute.

I. KO CUP

- 1. All rules A H apply except that:
- 1.1. No senior male players can play in the Women's KO Cup competition.
- 1.2. No senior female players can play in the Men's KO Cup competition.
- 2. All KO Cup players must be registered with the club before 1st February to be eligible to play for that club in any of that season's KO Cup matches.
- 3. A player who has played for a team in the KO Cup may not (even if transferred to another club) play for another team in the KO Cup that season.
- 4. The KO Cup competition is only open to those clubs who play in one of the HVA leagues.
- 5. Opposing teams will share venue costs.
- 6. Officials for all KO Cup matches must be neutral and qualified and shall be organised by the home side, as defined during the cup draw. Opposing teams will share the cost of officials. For the Cup Final, first and second referees are provided and paid for by the HVA, with line judges and scorers drawn from the men's finals team for the women and vice versa.
- 7. For the KO Cup finals, each club must supply two line judges and a scorer to officiate at the other KO Cup final match.
- 8. Multiple teams from the same club in the Cup play as separate teams. The Team Player Restrictions defined in C5 do not apply and rules at I3 apply instead.

J. GOODWILL DEPOSIT

- 1. All clubs will make a deposit of £30, from which any HVA fines are taken.
- 2. The deposit is carried over between seasons. It must be made back up to the full amount at the start of each season.
- 3. This deposit (or any season top-up) will be invoiced along with club registration fees as both must be paid before any competitive match is played.
- 4. A club can withdraw its current goodwill deposit balance at any time. This request must be made in writing to the Treasurer.
- 5. If a club's deposit is reduced to a zero or has a negative balance, the club is deemed to be in breach of not paying their Goodwill Deposit and the deposit must be made back up to its full amount before the breach is considered resolved. **See K12.**
- 6. Any HVA executive member can issue a fine with no need to notify the club in advance of their intention to do so.
- 7. The Treasurer will maintain the current balance of each club's Goodwill Deposit. It is also record on the HVA website.
- 7.1. The Treasurer or other HVA committee member will notify the club in writing of any fine and of their balance after the fine is applied.
- 7.2. The Treasurer will report on each club's current deposit balance as part of their report at each committee meeting.
- 8. Any fine can be disputed by the affected club. The fine remains imposed until the dispute is upheld by the committee.

Appendix A: Team Player Restrictions

This Appendix explains the team player restriction rules defined in section C5, which were introduced for the 2018/19 season. It does not replace or override those rules but aims to explain why they have been introduced and how they will operate. There is a worked example on the next page.

Introduction

Don't think of the team player restrictions as indicating a player is "locked" to a team like in previous seasons; it merely reflects the team to which a player "belongs".

The new rules are to encourage a <u>core</u> group of players to play as a team within the league, whilst providing flexibility to draw on other club players when team numbers are low for a fixture. The HVA feel that players assigned to a specific team should make up more than half the players on the court, hence 4 players. There's a bit of flexibility added for libero players because their usage during a match cannot be determined from the scoresheet.

The Competitions Secretary will check for breaches of the rules on confirming the fixture result, by checking the scoresheet for starting players and substitutions. It is up to the team to make sure they do not breach the rules as a breach means they will concede that set 0-25. Neither the opposition nor officials have any responsibility for checking for breaches before, during or after a match.

Player Registration

Every player can optionally be assigned a team when added to the club roster. When an unregistered player plays their first match for a team, they are added to the club roster and assigned to that team, and when a registered, but unassigned player plays their first match, they are also assigned to that team.

It is in the interest of the club to pre-register and assign players to a team in advance, so they are assigned to the team the club would <u>normally</u> expect them to play for, rather than the team they <u>first</u> play for. Pre-registering players also has the benefit that the player is then eligible to play in the KO Cup (if performed before the noted deadline), even if they haven't played before that deadline. As stated in the rules, you cannot change a team assignment without good reason.

Benefits

The new rules prevent the same group of players playing as two different teams between divisions.

As an individual player can play up/across/down as many times as required, there is no need for the club or HVA to monitor how many matches a player has played for each team. As individual players no longer get locked to a team after a certain number of matches, player availability does not diminish as the season progresses and clubs should not find it so difficult to get a team together, thus avoiding fixture changes or cancellations.

The HVA think the new rules should allow a team to operate with a slightly smaller squad than in previous seasons and we're hopeful this may encourage some clubs to enter additional teams. The rules should enable a new/improving player to play up through the club more easily encouraging player progression.

HISTORY OF AMENDMENTS

AGM 2025

Revised

- A3. A reminder that the rules change regularly and clubs need to be aware of the current rules.
- B1. England Volleyball no longer provide registration certificates, so the requirement here is clarified.
- C1. is revised to clarify players can only be registered to a single club (with one exception).
- C6. corrected to list NVL Super League and London Premier Division. This had already been applied for the previous season via a rule update on the website.
- C9. the rules for the Mixed League have been brought in line with all other leagues; player restrictions now apply. The minimum requirement for women and junior players has been reduced from 3 players to 2 players.

Section D has been re-written extensively to accommodate the removal of the requirement for teams to confirm home and away matches at 21 and 14 days respectively. Items that were tied to those deadlines were removed/reworded both in Section D and Section K.

- A4. To note that in-season rule corrections and clarifications will be clearly communicated.
- F1. Officials added for Men's Division 3. This had already been applied for the previous season via a rule update on the website.

- C6. Changed from "NVL Super 8 and SVA Division 1" to "NVL Division 1, SVA Division 1 and LVA Division 1".
- C7.2 Added reference to I1.1 for clarity.

- C8.3 and C8.4 The "junior clauses" added in 2023 are removed, along with associated references.
- E6 and K5. Incorrect net height added to the section and fines regarding equipment.
- E11.1 and E11.2 Revised rule to record and initial a time on the scoresheet for Time Restricted Venues.
- 16. Clarified that HVA provide refs for the Cup Finals.
- K1. Fine for not having a qualified first referee (when required and on complaint), increased to £20.

Added

- D11 and K13. Addition of a fine for away teams who fail to show up to a fixture and have not provided 72 hours' notice.

- B1. "The England Volleyball Association" changed to "England Volleyball".
- B3. The club's invoice for the season's competitions must be paid before the club's first competitive match.
- C1. Added references to amended C7.3 and new C8.4.
- C2. Player transfers "before 1 February and must be confirmed before the player plays for the new club" rather than simply "before the end of January". Date matches I2. Reference to new C8.4 is added.
- C4. Removed the "or by request in writing to the Competitions Secretary" for the addition of new players to the roster. This can be done online; don't pass this work to the Competitions Secretary.
- C7.1. "Men" changed to "Senior Men". See addition of C8.3 and C8.4.
- C7.3. Added "They are considered two different players when it comes to MVP awards."
- C11. The maximum number of conceded match sets recorded for playing an ineligible player is 3.
- D10. The Competitions Secretary will set a date for any league fixtures not communicated before 1 November.

- E4. Clarify that shirts should be numbered uniquely. Added requirement that Libero shirts must be significantly different. Added desire for club uniforms.
- F1. It is now a requirement for Division 1 Men's matches have a second referee present.
- F5: You can no longer ask the HVA to upload match results for you. The responsibility lies with the home team. The HVA will still assist if there are difficulties in doing this.
- G5.2. MVP designation changed to reflect what all teams are doing anyway; write them in the remarks section of the scoresheet.
- I1.1 and 1.2 gender restrictions removed from eligibility to play in Cup matches. This now says no Senior Men can play in the Women's Cup and no Senior Women can play in the Men's Cup.
- I2. Changed the cup registration date from 1 March to 1 February. Date matches the player transfer date at C2. Clarified that this is for any KO Cup match.
- I5. Cup court requirements changed to be the same as league requirements as it implied that DIv1 venue requirements were different to other divisions, which they are not. Confirmed that venue costs for cup matches should be shared.
- J3. Reworded as both the goodwill deposit and competition fees must be paid before a club's first competitive match is played.
- K1. Amended the conditions of a fine due to incorrect or unsuitable officials due to the change made at F1.
- K2. Removed reference to C2, which has nothing to do with this. Reference corrected from E11 to E12.
- K5. New fine for incorrect match ball.
- K11. Changed to say "set conceded" rather than "match forfeit" due to playing an ineligible player. Corrected reference from C10 to C11.

Appendix A. Corrected to say that playing an ineligible player means the set is conceded, rather than the match forfeit. A few minor changes.

New

- C8.3. A Junior player can play as part of a Women's Cup team, unless they are on the national pathway or equivalent.
