LEAGUE Rule Changes Proposed

I. KO CUP

2. Players registering with a club after 1st February will not be eligible to play for that club in that season's KO Cup.

(Think we are all happy with this wording?)

3. All KO Cup players registered before 1st February must have played at least one game (league or Cup).

I would propose that this is changed to All KO Cup players registered before 1st February must have played at least one league game before the 1st of February.

D. MATCH ARRANGEMENT

- 3. The home team is responsible for:
- e) Sending match information to the opposing team, in writing at least 21 days before the match date.

This is not done. I propose it is removed.

f) Informing the Competition Secretary, in writing or email of any changes to the match details from the published fixture list.

Does Phil still want this, if not then I propose it is removed

4. The away team is responsible for confirming match information, in writing at least 14 days before the scheduled match date.

I propose this is changed to "in writing or email at least 7 days"

5. All leagues fixtures must be completed two weeks before the KO Cup final. Any games not completed after that deadline will be declared null and

I propose this is removed

E. MATCHES OFFICIATION

4. All shirts to be numbered as per FIVB "Rules of the Game"

I propose this is removed

F. OFFICIALS

3.1 For all other divisions two officials are required (1st and 2nd referees), although these can be members of the home club.

I propose this is changed to "one official"
